- 1. Meeting called to order by President Wilson Lee at 1:34 PM.
- 2. Establish quorum: The number of voting members in attendance exceeds the minimum required for a quorum. **Quorum established.**
- 3. **Motion:** Approve Meeting Minutes from last <u>General Membership meeting at the NACAC</u> <u>Annual Conference</u>, September 26, 2024, from President Wilson Lee. *Motion Approved*.
- 4. Welcome comments from Wilson Lee, President
- 5. **NACAC Update** from visiting delegate from NACAC: Murphy Miller, Director of Membership Experience and Global Engagement.
 - a. International membership has grown and NACAC is continuing to host global fairs.
 - b. The 2025 NACAC Rising Star Program award will be awarded to the International ACAC Annual Conference Book Drive.

 - a. History and rationale for the board restructure

 - a. There are new subcommittees this year to focus on specific association goals.

 - a. Review of association budget.

 - a. Membership numbers continue to grow.
 - b. Division of members by member type (pie chart here)
 - Secondary = 48.2%
 - Post-Secondary = 33.2%
 - Individual = 8.9%
 - For-Profit Organization = 5.3%
 - Non-Profit Organization = 1.9%
 - Community Based Organization = 1.5%
 - Retired Professional = 1.0%
 - c. Division of members by region (pie chart here)
 - Canada and the US = 39.2%
 - East Asia = 17.8%
 - Europe = 16.3%
 - Southeast Asia and Oceania = 7.6%
 - South and Central Asia = 5.5%
 - Middle East and North Africa = 4.5%
 - South America = 3.6%
 - Caribbean, South America, and Mexico = 2.2%
 - d. Membership Data Goals:
 - Membership data clean-up and creating systems to maintain these processes annually
 - Review of membership categories
 - Ongoing review of membership fees
 - e. Member Engagement Goals:
 - Grow membership in underrepresented regions
 - More engagement opportunities for new members
 - Improve conference experience and regional institute experiences
- 15. Vice President Report: Marsha Oshima, Vice President for Professional Development
 - a. Year In Review:
 - We hosted a record number of webinars this year.
 - Other programs continue to go strong, including the Counselor Bus Tour,
 Pre-Conference Institute, and Mentor Year Program.
- 16. Vice President Report: Joyce Agyare, Vice President for Support, Access, and Success
 - a. The Scholar Program is continuing to bring members from around the world to the annual conference.
 - b. The 2026 scholar cohort has already been selected from those who experienced visa issues in 2025.

- We can now operate the program a year in advance, offering that cohort mentorship for a year ahead of their conference attendance.
- This also increases the likelihood of securing visas, which is historically the most common reason for Scholars to be unable to attend.

- a. There will be two election cycles this upcoming year.
 - Election for the Regional Representatives within the Regional Council
 - 1. 8 positions will be available, according to the new regions.
 - 2. Applications will be open from July 31 to August 14.
