While the largest percentage of our membership is still categorized as secondary and post-secondary members, we have also seen a small amount of growth in for-profit and non-profit organizations. We saw a small dip in new membership in 2021, likely due to the pandemic, but our 2022 projections (based on data through September) show overall new membership rebounding.

- ii. Scholars are high impact counselors who are working in under-resourced communities; recipients are funded to attend the Annual International ACAC Pre-Conference Institute and Conference either virtually or in-person.
- iii. Scholars who attend the conference in-person additionally participate in a higher education counselor bus tour following the conference.
